For supply of 3-5 kg Fuzz / True Seed (50,000 Expected Seedling) from Brazil

The bids shall be accepted till 11:00 AM of 26 January 2022 and shall be opened on the same date at 11.30 AM in the presence of the bidders. Bids will be opened on the prescribed time without regard to the number of the bidders present on that time. So, every bidder wishing to participate shall reach before prescribed time & sign attendance sheet to attend the bids opening.

1. Rates quoted shall be valid for at least 120 days from the close of bidding date.
2. All taxes shall be deducted by "SR&DB" while making payment as per government rules.
3. Successful bidder supplies the items within 2-3 month after issuance of supply order.
4. The quantity of the items in this bidding document may be increased or decreased as per the availability of funds and for any other reason.
5. The Chief Executive Officer, SR&DB Faisalabad reserves the right to reject all bids at any time prior to acceptance of the bids.
6. Total estimated costs in this bidding document is calculated considering all taxes.
7. Offered prices shall be inclusive of all the taxes, Import duty and other charges.
8. Supplies should be made within stipulated time as given Supply Order in consequence of acceptance of the bid. The bidder shall quote service charges in percentage. The bidder with lowest percentage charges will be awarded the contract. State Bank of Pakistan selling conversion rate on supply order's date will be used for calculating of services charges and payment.
9. If the bidder whose bid is accepted fails to deliver within time stipulated in Supply Order, his acceptance may be rejected and may be given to the second successful bidder and his bid security will be forfeited.
10. All PPRA rules are applicable and overrides these terms & conditions wherever contradictory
11. Payment will be made after receiving of goods and after having inspection that good supplied are as per prescribed specification.
12. The successful bidder is required to furnish a Performance Guarantee of 2% (quoted price) in the form of call deposit / pay order/ Banker's cheque, bank guarantee in favor of Sugarcane Research & Development Board. Bid security can also be adjusted in performance guarantee.

## **INSTRUCTIONS TO THE BIDDERS**

- Sealed bids are invited from eligible firms / Importers on active taxpayer list (ATL) and registered with FBR/PRA for the supply of 3-5 kg Fuzz / True Seed (50,000 Expected Seedling) from Brazil.
- Punjab Procurement Rules, 2014 will be strictly followed. These may be obtained from 'PPRA's website.
- Bidding documents may be purchased from the office of "Chief Executive Officer, Sugarcane Research and Development Board" Ayub Agricultural Research Institute, Jhang Road, Faisalabad during office hours (9:00 Am to 5:00 Pm) from Monday to Friday, on payment of Rs. 1,000/- cash only (Non-Refundable).
- 2% bid security/earnest money of the total estimated cost (RS. 10,783,980) must be attached in form of CDR with the tender in the favor of "Sugarcane Research and Development Board Punjab", without earnest money tender will be rejected.
- The price will be quoted in the Pak. Rupees Including all taxes/duties as per rules, as per Govt of the Punjab and relevant authorities as well as including transportation.
- The successful bidders will be required to import/supply item within 120-150 days from the date of supply order,
- If a bidder withdraws its bid during the period for bid validity or fails to supply the items the same will be declared black listed/banned.
- Items offered should be according to the specification and country of origin should be mentioned in the bid.
- Attach copy of registration with FBR and proof of enlistment on ATL with the technical bid, otherwise procuring agency may reject the bid. No alternate option will be accepted.
- The bid shall remain valid for 120 days from last date of tender opening. The bid shall be typed and be signed by the bidder or a person or person's duty authorized on behalf of the bidder.
- Any bid received after due date and time shall not be considered.
- The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon the request communicate to any supplier or contractor who submit a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
- The office will be not responsible for any expenses incurred by bidders in connection with the preparation/delivery of bids.
- Original tender documents each and every page duly signed/stamp must be attached with bid.
- At any time before the closing date, the procuring agency may modify the bidding documents either in response to the clarification by any bidder or at its own.
